Tackling Early School Leaving through entrepreneurial education: first meeting of the Student Talent Bank Project



On the 23rd and 24th of November, the project partners held the first kickoff meeting of the Student Bank Project at the European Youth Center in Strasbourg, France. The event offered the partners the opportunity to talk about the first phases of the project, the next actions to be taken and how to ensure its success. Also, this has been the first-time partners had the opportunity to meet face to face.

The Student Talent Bank is funded by the Erasmus+ Programme and focuses on promoting entrepreneurial education in secondary schools among teachers in order to prevent early school leaving, facilitate the transition from school to work and increase students' engagement.

New European recommendations on enhancing collaborative teaching and learning in schools



The CO-LAB project explores what collaborative teaching and learning means in practice in six European countries (Austria, Belgium (Flanders), Estonia, Ireland, Poland and Portugal). For this reason, **the recommendations to provide a systemic approach to support the widespread implementation of collaborative learning across schools**, at all levels of the system: policy, teachers' training, school and classroom were published.

Among the most important factors to enhance collaborative teaching and learning in schools is fostering collaborative school culture, encouraging collaboration across the learning community involving teachers, administrators, technical staff and parents, as well as wider stakeholders from e.g. local education authorities.

Syllabus for entrepreneurial education in secondary schools

On the 28th March 2018, the MIUR (the Italian Ministry of Education, University and Research) published the first syllabus to make entrepreneurial education a structural subject into secondary school education.

Thanks to the syllabus, schools will be supported in building learning path to make the students develop the abilities and competences to transform their ideas into action, increasing their creativity, innovation and risk-taking behaviour.

The syllabus is divided in 5 areas:

1. Business Opportunity;
2. Idea development, context and social needs;
3. From the idea to the market: resources and competences;
4. Market analysis;
5. Economic citizenship
